Discuss, consider and possible action on Resolution No 2021-23, approving a contract with Sweeping Corp of America (SCA) to sweep streets within city limits and authorize the Mayor to sign.

Motion made by Councilmember Allen, seconded by Councilmember Allen to approve the SCA agreement with the change that it start January 1, 2022 and the contract term be for one year with option to automatic renew for another year. The motion was approved unanimously.

Motion made by Councilmember Adams, seconded by Councilmember Allen, to approve the SCA contract with the changes and to start January 2022. The motion was approved unanimously.

Motion made by Mayor Pro Tem Matthys, seconded by Councilmember Allen to approve Resolution No. 2021-27, bid from Weaver & Jacobs Constructors and to include the alternate bid of \$30,000. The motion was approved unanimously.
