

RESOLUTION-2022-08

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS, APPROVING A CONTRACT BETWEEN THE CITY OF CUERO AND PUBLIC MANAGEMENT, INC. FOR PROFESSIONAL GRANT APPLICATION PREPARATION AND ADMINISTRATIVE SERVICES FOR THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM(TXCDBG) FOR THE DOWNTOWN REVITALIZATION PROGRAM IN THE CITY OF CUERO.

WHEREAS, the City of Cuero("City") desires to obtain professional services for grant application preparation associated with the Texas Community Development Block Grant Program(TxCDBG)-Downtown Revitalization Program administered by the Texas Department of Agriculture; and

WHEREAS, the City is in need of professional grant application preparation and administrative services to identify, pursue and implement funding opportunities that address community development goals and needs, which include such grant application services for the Texas Community Development Block Grant(TxCDBG) for the City's Downtown Revitalization Program; and

WHEREAS, the City has received a proposal for such professional grant administration services from Public Management, Inc., a Texas Corporation; and

WHEREAS, the City has acted in accordance with the requirements of Section 2254.001 et seq, of the Texas Government Code, cited as the Professional Services Procurement Act, in reviewing such proposal from Public Management, Inc.; and

WHEREAS, professional grant application services are vital and essential to the City; and

WHEREAS, the City finds it is in the best interest of the City to approve the proposal from Public Management, Inc. for grant application preparation and administrative services for the Texas Community Development Block Grant (TXCDBG) Downtown Revitalization Program; and

WHEREAS, the said Professional Services and Proposed Plan and Contract for the Texas Community Development Block Grant (TXCDBG) Downtown Revitalization Program is attached hereto as **Exhibit "A"**; and

WHEREAS, the governing body of the City of Cuero after careful consideration and negotiation with Public Management, Inc. does hereby approve the Contract between the City of Cuero and Public Management, Inc. in the form attached hereto as **Exhibit "A"**, with attached addendum and exhibits;

WHEREAS, the governing body of the City does hereby authorize the Mayor to execute said contract on behalf of the City and all associated documents.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS:

That this City Council does find that the City has fully complied with all applicable laws regarding the approval of Public Management, Inc. for the professional Application and Administration Services described herein.

That the City Council does hereby APPROVE the contract in the form attached hereto as **Exhibit “A”** with Public Management, Inc. for professional grant application preparation and administrative services that will identify, pursue and implement funding opportunities that address community development goals and needs, which include such grant application services for the Texas Community Development Block Grant Program(TxCDBG)—Downtown Revitalization Program(DRP), administered by the Texas Department of Agriculture.

That this City Council of the City of Cuero does hereby authorize the Mayor to execute the contract in the form attached hereto as **Exhibit “A”** and all associated documents and attached exhibits and addendums on behalf of the City of Cuero.
