A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS AUTHORIZING AND APPROVING A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF CUERO AND TANK INDUSTRY CONSULTANTS FOR PROFESSIONAL ENGINEERING DESIGN SERVICES AND BIDDING SERVICES ASSOCIATED WITH THE REHABILITATION OF INDUSTRIAL AND ELEVATED GROUND WATER STORAGE TANKS UTILIZED BY THE CITY OF CUERO.

WHEREAS, the City of Cuero("City") desires to obtain professional engineering design services and bidding services associated with the rehabilitation of its industrial and elevated ground water storage tank(s) utilized by the City of Cuero; and

WHEREAS, the City has received a proposal, including a statement of qualifications for such professional engineering services from Tank Industry Consultants; and

WHEREAS, Tank Industry Consultants specializes in water tank rehabilitation; and

WHEREAS, the City has acted in accordance with the requirements of Section 2254.001 et seq, of the Texas Government Code, cited as the Professional Services Procurement Act, in reviewing the competence and qualifications of Tank Industry Consultants; and

WHEREAS, professional engineering services are vital and essential to the City; and

WHEREAS, the City finds it is in the best interest of the City to approve and designate Tank Industry Consultants for professional engineering services applicable to design services and bidding services associated with the rehabilitation of industrial and elevated ground water storage tanks utilized by the City of Cuero; and

WHEREAS, the governing body of the City of Cuero after careful consideration does hereby approve and designate Tank Industry Consultants as the engineering firm to provide professional engineering services and bidding services associated with and applicable to the rehabilitation of industrial and elevated ground water storage tanks utilized by the City of Cuero; and

WHEREAS, the governing body of the City approves a professional services agreement between the City of Cuero and Tank Industry Consultants in the form attached hereto as Exhibit A and incorporated herein at length for all purposes as if fully set forth, with its attached Exhibits, if any; and

WHEREAS, the governing body of the City does hereby authorize the CITY MANAGER to execute the agreement and applicable documentation on behalf of the City and all associated documents; and

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CUERO, THAT:

That this City Council does find that it has fully complied with all applicable laws regarding the approval of Tank Industry Consultants for professional engineering services and bidding services associated with and applicable to the rehabilitation of its industrial and elevated ground water storage tanks utilized by the City of Cuero.

That the governing body of the City of Cuero does hereby approve the Agreement between the City of Cuero and Tank Industry Consultants in the form attached hereto as Exhibit A, with its attached exhibits, if any, associated with and applicable to the rehabilitation of its industrial and elevated ground water storage tanks utilized by the City of Cuero.

That the CITY MANAGER is hereby authorized to execute the said agreement and any associated documents on behalf of the City with the City Secretary attesting to same.
