



**ORDINANCE NO. 2022- 11**

**AN ORDINANCE OF THE CITY OF CUERO, TEXAS, ADOPTING A BUDGET FOR THE FISCAL YEAR 2022-2023 BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023, APPROPRIATING THE VARIOUS REVENUE AND EXPENDITURE AMOUNTS THEREOF AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH PROVIDING FOR AN EFFECTIVE DATE, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City Manager of the City of Cuero, Texas, hereinafter the “City”, has submitted to the City Council a proposed budget of the revenues and expenditures for the Fiscal Year 2022-2023, beginning October 1, 2022 and ending September 30, 2023, to conduct and support the affairs of the City and has provided a financial plan for the City for the Fiscal Year 2022-2023; and

**WHEREAS**, the proposed Fiscal Year 2022-2023 Budget has been compiled from information obtained from the departments and offices of the City; and

**WHEREAS**, the City Council has received the City Manager’s proposed Fiscal Year 2022-2023 Budget, a copy of which has been filed with the City Secretary; and

**WHEREAS**, the City Council has conducted public hearings on the budget, as provided by law; and

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS, THAT:**

**Section One.** The Fiscal Year 2022-2023 Budget, beginning October 1, 2022 and ending September 30, 2023, a copy which is attached hereto as Exhibit “A” is hereby adopted.

**THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR’S BUDGET BY \$127,941\_OR 12.42 % AND OF THAT AMOUNT, \$12,618 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.**

**Section Two.** The sums shown in Exhibit “A” are hereby appropriated for the respective City funds included for the payment of expenditures on behalf of the City as established in the approved budget document for the Fiscal Year 2021-2022.

**Section Three.** Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**Section Four.** This ordinance shall be and remain in full force and effect from and after its final passage and publication as herein provided.

**Section Five.** It being necessary that the Fiscal Year 2022-2023 Budget shall be adopted immediately, in order to continue to conduct the financial affairs of the City in an efficient manner, without disruption, an emergency exists for the preservation of public business, health and safety thereby demanding that the rule which requires an Ordinance be read at more than one (1) meeting of the City Council be and the same is hereby suspended and this Ordinance shall take effect immediately upon and after its passage.
