

**RESOLUTION NO. 2022-27**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS APPROVING AND ACCEPTING A PROPOSAL FROM KINLOCH EQUIPMENT & SUPPLY, INC. FOR THE LEASE/PURCHASE OF THE ELGIN BROOM BEAR TRUCK MOUNTED MECHANICAL SWEEPER AS THOSE TERMS ARE DESCRIBED IN EXHIBIT “A” ATTACHED HERETO AND AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT WITH KINLOCH EQUIPMENT & SUPPLY, INC. AS ATTACHED TO THIS RESOLUTION AS EXHIBIT “A”.**

**WHEREAS**, the City of Cuero (“City”) has received a proposal from Kinloch Equipment & Supply, Inc. for the Elgin Broom Bear truck mounted mechanical sweeper under those terms as provided in Exhibit “A” attached hereto; and

**WHEREAS**, the City has acted in accordance with the requirements of applicable law in procuring such proposal; and

**WHEREAS**, after reviewing the proposal received, the City accepts and approves the proposal received from Kinloch Equipment & Supply, Inc. for the lease/purchase of the Elgin Broom Bear truck mounted mechanical sweeper as described in Exhibit “A”; and

**WHEREAS**, the Mayor is hereby authorized to execute said Agreement with Kinloch Equipment and Supply, Inc.; and
