1. Invocation

City Attorney James Crain gave the invocation.

2. Pledge Of Allegiance

Councilmember Emil Garza led the pledges.

3. Public Comments

Cuero Development Corporation Director, Bobby Seiferman informed Council that the City of Cuero Received recognition as being one of the best small towns to visit in 2020.

Motion made by Mayor Pro Tem Matthys, seconded by Councilmember Garza, to appoint W. T. "Tony" Allen to fill the remaining term left by Brad Hedrick who moved outside the city. The motion was approved unanimously.

7. Council Consideration And Action Items

7.1. Discuss, Consider And Possible Action On Request To Close The 200 Block Of E. Main And 100 Block Of S. Gonzales For The Ruby Selection Day, To Be Held July 24, 2021. Turkey Fest Is Also Requesting Permission To Build Another Outside Stage For The Turkey Fest In October.

Turkey Fest representatives, Brenda Martin, James Rath, Angie Cuellar and ShaNon Henson were present to ask Council permission to add another stage outside on the knoll in the park. The freedom and flag scenes would have to be taken down. They also asked to close down the 100 block of E. Main and Gonzales Streets so that they could have the turkey selection.

Motion made by Councilmember Garza, seconded by Councilmember Fuqua to table the item regarding the stage. The motion was approved unanimously.

Motion made by Mayor Pro Tem Matthys, seconded by Councilmember Fuqua, to allow the 100 block of E. Main and Gonzales to be closed on July 24, 2021 from 5:pm to 10:pm and for the Turkey Fest representatives to meet with the Police Chief and City Manager before the event. the motion was approved unanimously.
