

ORDINANCE NO. 2008 - 13

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS, AMENDING TITLE V, CHAPTER 52, SECTION 52.60 (C) SEWER SERVICE CHARGES, AND CHAPTER 53, SECTION 53.55 (E) (1) RATES FOR WATER SERVICE, OF THE CITY OF CUERO CODE OF ORDINANCES PRESCRIBING RATES AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS:

SECTION ONE. That Title V, Chapter 52, Section 52.60 (C) Sewer Service Charges and Chapter 53, Section 53.55 (E) (1) Rates for Water Service of Title V, Chapter 53 of the Code of Ordinances of the City of Cuero, Texas, be and the same are hereby amended to read as follows:

CHAPTER 52.60 SEWER SERVICE CHARGES.

(C) Using such bases, the charge for sewer service shall be:

(1) Customer Inside City.

Residential & Commercial:

First 2,000 Gallons	\$11.82
For each 1,000 gallons or fraction thereof in excess of 2,000 gallons	\$1.25

(2) Customers Outside City.

Residential:

First 2,000 Gallons	\$13.44
For each 1,000 gallons or fraction thereof in excess of 2,000 gallons	\$2.08

Commercial:

First 2,000 Gallons	\$21.60
For each 1,000 gallons or fraction thereof in Excess of 2,000 gallons	\$2.08

CHAPTER 53.55 RATES FOR WATER SERVICE.

(E) The following charges and rates for water furnished by the city are hereby fixed as follows:

(1) Customers Inside City.

Residential:

Monthly Service Charge:	\$9.74
Gallonage Charge (Per 1,000 gallons)	\$1.66

Commercial:

Monthly Service Charge:	\$16.91
Gallage Charge (Per 1,000 gallons)	\$1.66

(2) Customers Outside City.

Residential:

Monthly Service Charge:	\$11.36
Gallage Charge (Per 1,000 gallons)	\$2.50

Commercial:

Monthly Service Charge:	\$21.60
Gallage Charge (Per 1,000 gallons)	\$2.50

SECTION TWO. Such amendment is immediately necessary in order to permit the City of Cuero to operate with a balanced budget as required by law and such fact constitutes an emergency for the preservation of public business, health, and safety, thereby demanding that the rule which requires an ordinance be read at more than one meeting of the City Council be and the same is hereby suspended and this ordinance shall take effect immediately upon and after its passage.

UPON MOTION OF COUNCILMEMBER RUIZ, SECONDED BY COUNCILMEMBER PENA, THAT THE ORDINANCE BE ADOPTED. AYES: 5 NAYES: 1-RIEMENSCHNEIDER MOTION CARRIED.
