

**RESOLUTION NO. 2020- 44**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUERO, TEXAS AUTHORIZING AND APPROVING A \$50,000 GRANT TO THE CUERO INDEPENDENT SCHOOL DISTRICT AS REQUESTED BY CUERO INDEPENDENT SCHOOL DISTRICT THROUGH THE CITY OF CUERO'S CARES ACT-COVID-19 GRANT ASSISTANCE PROGRAM AND AUTHORIZING THE CITY'S FINANCE MANAGER TO SIGN AND SUBMIT ALL DOCUMENTS ASSOCIATED THEREWITH ON BEHALF OF THE CITY OF CUERO.**

**WHEREAS**, the City of Cuero applied for and is eligible for funding under section 601(a) of the Social Security Act, as added by Section 5001 of the Coronavirus Aid, Relief and Economic Security Act("Cares Act"); and

**WHEREAS**, the Cuero Independent School District has requested Cares Act-Covid-19 Grant Assistance from the City of Cuero in the amount of **\$50,000.00** to help with expenses related to COVID-19 related health measures, to include expenses to facilitate distance learning, including technological improvements, in connection with school closing to enable compliance with COVID-19 precautions, including the purchase of HP Chrome Books, Apple iPads and Verizon hotspots to provide remote learning to students of Cuero Independent School District; and

**WHEREAS**, the governing body of the City does hereby approve a grant in the amount of **\$50,000.00** to the Cuero Independent School District through the City of Cuero's Cares ACT-Covid-19 Grant Assistance Program to be used for expenses related to COVID-19 related health measures, to include expenses to facilitate distance learning, including technological improvements, in connection with school closing to enable compliance with COVID-19 precautions, including the purchase of HP Chrome Books, Apple iPads and Verizon hotspots to provide remote learning to students of Cuero Independent School District;

**WHEREAS**, the governing body of the City does hereby authorize the City Finance Manager to sign and submit all applicable documents on behalf of the City.

That the City Council of the City does hereby approve a grant in the amount of **\$50,000.00** to the Cuero Independent School District through the City of Cuero's Cares ACT-Covid-19 Grant Assistance Program to be used for expenses related to COVID-19 related health measures, to include expenses to facilitate distance learning, including technological improvements, in connection with school closing to enable compliance with COVID-19 precautions, including the purchase of HP Chrome Books, Apple iPads and Verizon hotspots to provide remote learning to students of Cuero Independent School District.
